COLREGS DEMARCATION LINE

The Inland Navigational Rules Act of 1980 is in effect for vessels transiting this area. The seaward boundaries of this area are the COLREGS demarcation lines. In the area seaward of the COLREGS demarcation lines, vessels are governed by COLREGS: International Regulations for Preventing Collisions at Sea, 1972. The COLREGS demarcation line is defined in COLREGS 33 CFR 80.740.

HURRICANES AND TROPICAL STORMS

Hurricanes, tropical storms and storms may cause other major considerable damage to marine structures, aids to navigation and moored vessels, resulting in submerged debris in unknown locations. Charted soundings, channel depths and shoreline may not reflect actual conditions following these storms. Fixed aids to navigation may have been damaged or destroyed. Buoys may have been moved from their charted positions, damaged, sunk, extinguished or otherwise made inoperative. Mariners should not rely upon the position or operation of an aid to navigation. Wrecks and submerged obstructions may have been displaced from charted locations. Pipelines may have become uncovered or moved. Mariners are urged to exercise extreme caution and are requested to report aids to navigation discrepancies and hazards to navigation to the nearest United States Coast Guard unit.

COLREGS DEMARCATION LINE

The Inland Navigational Rules Act of 1980 is in effect for vessels transiting this area. The seaward boundaries of this area are the COLREGS demarcation lines. In the area seaward of the COLREGS demarcation lines, vessels are governed by COLREGS: International Regulations for Preventing Collisions at Sea, 1972. The COLREGS demarcation line is defined in COLREGS 33 CFR 80.745a.

CORAL PROPAGATION

Uncharted submerged manmade structures, designed for the purpose of coral propagation, may exist within the limits of this chart, principally in shallow water areas.

INTRACOASTAL WATERWAY AIDS

The U.S. Aids to Navigation System is designed for use with nautical charts, and the exact meaning of an aid to navigation may not be clear unless the appropriate chart is consulted. Aids to navigation marking the Intracoastal Waterway exhibit unique yellow symbols to distinguish them from aids marking other waterways. When following the Intracoastal Waterway southward from Norfolk, VA to Cross Bank, FL, aids with yellow triangles should be kept on the starboard side of the vessel and aids with yellow squares should be kept on the port side of the vessel. A horizontal yellow band provides no lateral information, but simply identifies aids to navigation as marking the Intracoastal Waterway.

CAUTION LIMITATIONS ON THE USE OF RADIO SIGNALS

Limitations on the use of radio signals as aids to marine navigation can be found in the U.S. Coast Guard Light Lists and National Geospatial-Intelligence Agency Publication 117.

Radio direction-finder bearings to commercial broadcasting stations are subject to error and should be used with caution.

CAUTION SHOALS AND PASSES

Mariners are advised to use caution in Florida Bay. The shoals and passes were obtained from reports and have not been verified by field surveys. Stakes and piles, marking passes, are not shown due to their frequent change in position.

EVERGLADES NATIONAL PARK WILDERNESS WATERWAY

A recommended inland water route from Flamingo (25°08'30"N, 80°55'30"W) to Everglades City (25°51'30"N, 81°23'15"W). Navigation of the route is not advisable for boats over 5.5 meters/18 feet in length, or for boats with high cabins and windshields, because of the narrow channels and overhanging foliage in some areas. The entire route can be traversed in a minimum of six hours with outboard motor, or in seven days by canoe. One day round trips are not recommended. Campsites are available along the route. For overnight use of campsites, a backcountry permit is required. The permit may be obtained at either Flamingo or Everglades City Ranger Stations.

CAUTION SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. Not all submarine pipelines and submarine cables are required to be buried, and those that were originally buried may have become exposed. Mariners should use extreme caution when operating vessels in depths of water comparable to their draft in areas where pipelines and cables may exist, and when anchoring, dragging or trawling.

Covered wells may be marked by lighted or unlighted buoys.

EVERGLADES NATIONAL PARK (PROTECTED AREA: 36 CFR 7.45)

For the protection of wildlife, all Keys in the Florida Bay portion of Everglades National Park are closed to landing except those marked as designated camping areas. A backcounty use permit is required for overnight camping and can be obtained at Park Ranger Stations. The killing, collecting, or molesting of animals, the collecting of plants, and waterskiing are prohibited by Federal Regulation.

NOTE

No water passage exists between the Broad and Shark Rivers. Passage must be made via the Gulf of Mexico.

CAPE SABLE

Primitive camping is allowed along beaches of Cape Sable. No facilities are available. Fires are permitted below the high tide line. Use only dead and down wood.
